ADDITIONAL FY19 QUOTAS AVAILABLE FOR MIDGRADE OFFICER & CIVILIAN TRANSITION COURSES (MOCTC) 1 & 2

MOCTC-1 (Course Code: 100139): 13 Quotas

The target audience for MOCTC-1 is O-3s, and O-4s that have recently assumed supervisory roles. The primary focus of MOCTC-1 is "Leading Self and Leading Others." It is delivered in a blended format over 16 weeks: seven weeks of online training, two-weeks of resident training, and a follow-on seven weeks of online training. Online coursework requires a 2-4 hour commitment per week.

MOCTC-2 (Course Code: 100140): 4 Quotas

The target audience for MOCTC-2 is O-4s. The primary focus of MOCTC-2 is "Leading Performance and Change and Leading the Coast Guard Competencies". It is delivered in a blended format over 22 weeks: 11 weeks of online training, three-weeks of resident training in Washington, DC, and a follow-on eight weeks of online training. Online coursework requires a 2-4 hour commitment per week.
